Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school from class I to X shall be restricted to 13 The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above.. Further, increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension. The school is directed to run atleast 01 section each of balvatika I, II & III in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
2	Ramp at entrance does not have safety handrails on both the side. Hence, the school is required to affix Safety handrails on both side of the Ramp (ref CBSE Circular No 11/2024 dated 09/08/2024) and submit compliance on SARAS Portal with videography.
3	The school has converted regular cubicles into CWSN toilets, but they are very narrow and there is no room for a wheelchair/walker to navigate. The school is required to construct the CwSN toilets separately for boys and girls as per norms of RPwD Act and Board's

	guidelines(ref CBSE Circular No 11/2024 dated 09/08/2024) within 03 months and submit the compliance.
4	Composite Science lab should have a permanent workstation with inbuilt utilities for Chemistry and Biology section and lab standard table for Physics section. Safety features is not adequate in the lab. More apparatus/kit needs to be added. Thus, the school is required to update the lab as per Board's SoP within 03 months and submit the compliance.
5	Math lab is a temporary arrangement, with equipment is displayed on tables and no proper workstations / adequate seating arrangements. No storage is seen. Thus, the school is required to update the lab as per Board's SoP within 03 months and submit the compliance.
6	Boundary wall from all the four side of the school Building is not seen in the video. The school must ensure of availability of Boundary wall of prescribed height (6 ft) from all the side and submit compliance on SARAS Portal with videography within 3 months.
7	School is required to appoint sufficient teachers (TGTs and others) as per norms of the Board, pay Salary to all staff and other statutory benefits through Bank Transfer and submit compliance on SARAS Portal within 3 months
8	As per report of IC, School is going to shift the Computer lab to an room of 54 sq mt. The school must ensure of set up Computer lab as well as availability of number of Computer as per circular no 10/2023 dated 24.03.2023 and submit compliance on SARAS Portal with videography within 3 months.
9	There is no separate reading space for staff is available in the Library. More Periodicals, Journals & newspapers should be added. The room is undersized as pointed out by IC members. Thus, the school is required to shift the set-up the same as per Board's SoP and submit the compliance within 03 months and submit the compliance.
10	School shall ensure validity of all essential certificates/documents all the time, take action for renewal of mandatory certificates from time to time and upload under Mandatory Public Disclosure on its websites in all the times including NOC, Recognition/Land/Building Safety/Fire Safety/Society Registration/Water & Sanitation Certificate etc and submit compliance on SARAS Portal.
11	The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws- 2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy

thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.

5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted within the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
